

§ 302-5: The use of sound amplifiers outside buildings within the Village of Allouez is prohibited without a permit to do so from the Village. The Village shall not grant a permit to use a sound amplifier during nighttime hours (10:00 p.m. to 7:00 a.m.) or to operate such sound amplifier in the vicinity of health facilities, churches while services are being conducted, or schools which are in session. The Village may order a reduction in the volume of such sound amplification on complaint being made by a citizen or when such sound amplification is a nuisance because of the volume, the method in which it is being used, or the location in which it is being operated.

Noise Variance Permit Application Request:

On April 14th, 2022, I, Deputy J. Vogel, spoke with applicant Kate Hogan via a telephone call in reference to her Noise Variance Permit Application. Kate had completed a Village of Allouez Noise Variance Application form for a wedding she will be hosting on June 25th, 2022. Kate's request was for amplified music speakers for the wedding in her front yard and empty lot in front of 3113 Stanton Ct. A tent will be set up in this empty lot with the DJ inside. Kate was requesting the time of operation from 4pm-11pm.

I spoke with Kate about my concerns about having the amplified music go past 10:00pm in a residential area. Kate agreed I could change the time on her form to 4:00pm to 10:00pm for outdoor music. Kate agreed to face the speakers west towards the Fox River and not at residential homes. Kate also agreed to notify her neighbors on Stanton Ct, Linck Ct, and Taft St via a letter in the mail about hosting a wedding at this address. Kate verified her contact information in case someone would need to be contacted on this day if complaints are made.

Currently, I am recommending approval of this application with the change of hours 4:00pm to 10:00pm.
